### **Private Pool Rental Information Sheet**

#### **Timeline for Booking Parties:**

All parties must be booked at least 72 hours in advance.

### **Payment and Cancellation Policy:**

Full payment is required at the time of reservation. Written cancellations must be made within 14 days of scheduled usage to receive a full refund (minus a \$5.00 administrative fee). If reservation is cancelled less than fourteen (14) days prior to the date reserved, no refund will be issued.

If unforeseen circumstances, a cancellation is initiated by Kearns Oquirrh Park Fitness Center, the reservation holder will be given a full refund.

### **Facility Rules & Swim Diapers:**

- Children, age 6 and under, must be accompanied and supervised by and adult (18+) all times including in the water at all times. Maximum adult ration of 1 adult per 3 children 6 & under. No exceptions.
- Maximum adult ratio of 1 adult per 3 children 6 and under. Children, ages 7-9, must have an adult (18+) supervisions ratio of at least 1 adult per 8 children when in the water. No exceptions
- Children or persons who lack control must wear a water resistance swim diaper and waterproof swim wear in the pool. Regulardiapers are not allowed in the pool. Children aquatic diapers and waterproof swim wear are available for purchase at the front counter.
- Children must be 10 + years to use diving platforms.
- Bags, backpacks, purses, photographic equipment (including phones), and coolers are subject to a reasonable search at any time by a KOPFC employee.
- For the comfort of all during hours of operation no amplified music (including but not limited to stereos, radios, portable budspeakers) is allowed. Patrons must use personal headphones.
- Severe weather may cause some attractions to close for periods of time. Management reserves the right to close the outdoor pool after a significant period of severe weather. Refunds are not issued due to weather unless we cancel your entire reservations.
- Alcoholic beverages and illegal substances, Glass items, Piñatas, are prohibited on facility property.
- BBQ grills prohibited on facility property.
- For additional rules in each department, please see signs posted within the facility.

## **Making Changes To Your Reservation:**

To make any changes or additions you need to make to your party, please call at least 72 hours in advance. Payment for additions must be paid prior to your party.

# **Party Time:**

- You are only allowed to be in the outdoor pool area for the time frame listed on the confirmation email.
- Early entry into the outdoor pool area is NOT allowed. Guests arriving early are welcome to wait outside our south kiosk entrance. If you arrive late, we cannot extend your scheduled party time.
- Chomper's Party Cove and Coca-Cola Pavilions are not available to use during private pool rentals.
- The usage of damaging items such as rice, confetti, loose beads, glitter, and tape on cement floor is prohibited. IF you have doubts, please ask!
- Balloons air and helium with approval for designated areas, please secure/anchor properly.
- Final guarantee and payment for private party wristbands is due 72 hours prior to your event

#### Supervision

Parties are not supervised, but a staff member will be available to help you during party if you need anything.

## Instructions For the day of Party:

- 1 Please check in at South Kiosk Entrance.
- 2 You will be asked to leave identification to secure payment for your group (if tally is necessary).
- 3 Let your guest know to identify themselves with your group.
- 4 At the end of your reservations, please review final tally and settle your bill.
