

## **Kearns Oquirrh Park Fitness Center Facility and Rental Rules**

- Children 9 and under must not be left unattended at any time in any area of the facility. Adult (18+) must also be actively engaged in supervising children 9 and under at all times.
- Children, age 6 and under, must be accompanied and supervised by an adult (18+) at all times including in the water at all times.
- Maximum adult ratio of 1 adult per 3 children 6 and under. Children, ages 7-9, must have an adult (18+) supervisions ratio of at least 1 adult per 8 children when in the water.
- Use of facility, activities, programs, and equipment are at your own risk. If you need assistance, please ask at the front counter or south entrance.
- As a public facility, smoking (includes e-cigarettes) is not permitted in the facility, tennis center, or outdoor pool areas.
- Civil Behavior is required of all patrons at all times in the facility.
- Swimsuits must be worn by all swimmers. Street clothes are not allowed in pools.
- KOPFC Management reserves the right to use discretion on unacceptable attire.
- Children or persons who lack control must wear a water-resistant swim diaper and waterproof swim wear in the pool. Regular diapers are not allowed in the pool. Children aquatic diapers and waterproof swim wear are available for purchase at the front counter.
- You are responsible for cleaning up your area and returning it to its original condition.
- You are responsible for any damage caused by your activity or any damage caused by your guests.
- Nails, tacks, pins, staples, scotch table, masking tape, or any other items that put holes on pavilions is strictly forbidden.
- Bags, backpacks, purses, photographic equipment (including phones), and coolers are subject to a reasonable search at any time by a KOPFC employee.
- For the comfort of all during hours of operation no amplified music (including but not limited to stereos, radios, portable loudspeakers) is allowed. Patrons must use personal headphones.
- Cancellations must be made within 14 days of scheduled usage to receive a full refund (minus a \$5.00 administrative fee). No refund will be given after this time.
- Severe weather may cause some attractions to close for periods of time. Management reserves the right to close the outdoor pool after a significant period of severe weather. Refunds are not issued due to weather.
- All spectators must pay general admissions.
- Alcoholic beverages and illegal substances, Glass items, Piñatas and open flame candles are prohibited on facility property.
- Power or water access is not available at Chomper's Party Cove & Coca-Cola Pavilion.
- Early entry to Chomper's Party Cove & Coca-Cola Pavilion is NOT allowed.
- You are only allowed to be in the Chomper's Party Cove & Coca-Cola Pavilion for the time frame listed on the confirmation email. You can purchase additional rental time based on availability.

## **Dive Pool:**

• Children must be 10+ years to use diving platforms.

- 2. You will be asked to leave identification to secure payment for group (if tally is necessary).
