\_\_\_\_\_ Pavilion is left in a clean and orderly condition.

\_\_\_\_\_ All trash shall be disposed of properly in trash cans.

\_\_\_\_\_ Group will make sure all picnic tables have no food/beverage particles/spills.

\_\_\_\_\_ Remove all party decorations from pavilion including table cloths, balloons, strings and tape. DO NOT USE tacks, staples, and/or nails to secure items to the pavilion walls/fencing.

\_\_\_\_\_ All personal possessions will be removed from under that pavilion after their event.

\_\_\_\_\_ The following items are prohibited to use on property: confetti and glitter

\_\_\_\_\_ All parties will forfeit their cleaning deposit if they stay past their rental agreement time.

\_\_\_\_\_ All cake icing, mustard, ketchup, condiment spills have been cleaned up.

Broom and cleaner available upon request.

**Cleaning/Security Deposit:**

The pavilion will be inspected immediately following your reservation and the cleaning/security deposit refund process will begin the following week. The refund may take up to 10 days to be processed. You will also be responsible for additional fees if damages are incurred at the facility.

**General Prohibitions:**

- No smoking/vaping or alcohol allowed on facility property
- No gambling, fighting, quarreling, or use of profane language permitted
- No use of BBQ Grills
- No Sound Amplification

**Supervision:**

Parties are not supervised, but a staff member will be available to help you during party if you need anything.

**Party Time:**

- You are only permitted to be in Chomper’s Party Cove & Coca-Cola Pavilions for the time frame listed on the confirmation email.
- Early entry into Chomper’s Party Cove & Coca-Cola Pavilions is NOT allowed unless you pre-pay at the Front Desk or Kiosk for the extra time you enter (1 hour segments only). Guests arriving early are welcome to wait outside our south kiosk entrance or pavilion areas if during open plunge hours. If you arrive late, we cannot extend your scheduled party time.
- Everyone must pay general admissions to come inside the facility whether swimming or not.
- Power or water access is not available at Chomper’s Party Cove & Coca-Cola Pavilion.
