RULES

- ✿ **All dogs must enter and exit the pool facility on a leash.**
- ✿ **All dogs must wear collars at all times**
- ✿ **Owners are responsible for all pet actions.**
- ✿ **Owners must be present and with their pets at all times.**
- ✿ **All pet handlers must be at least 18 years old or accompanied by an adult.**
- ✿ **All dogs must have current proof of vaccinations.**
- ✿ **No aggressive dogs or female dogs in heat are allowed.**
- ✿ **Owners must pick up all droppings.**
- ✿ **Handler is limited to no more than 2 dogs.**
- ✿ **People are not allowed in the pools at all.**
- ✿ **Pool safety rules will be enforced**
- ✿ **Babies, toddlers and children under the age of 12 are cautioned not to attend as they can easily be knocked over by running dogs.**

Each participant is responsible for the actions of the dog they have registered. Oquirrh Recreation and Parks District, dba Kearns Oquirrh Park Fitness Center, does not assume any responsibility for the actions of any of the dogs on the premises. All dogs must be non-aggressive and in good health. All dogs must be up to date on vaccinations. If your dog has not been spayed or neutered, you are responsible for the actions of your dog and any misfortunes caused by or to your dog from other dogs. No females in heat will be allowed onto the premises. Oquirrh Recreation and Parks District, dba Kearns Oquirrh Park Fitness Center, reserves the right to refuse any dog. Registrants and their accompanying family members, friends and pets participating in Doggy Paddle Day to be held at Oquirrh Recreation and Parks District, dba Kearns Oquirrh Park Fitness Center, on **Saturday, September 10, 2022**, hereby assume full responsibility for the risk of bodily injury, death or property damage and hereby release, waive, discharge and covenant not to sue Oquirrh Recreation and Parks District, dba Kearns Oquirrh Park Fitness Center, or their respective successors, assignees, officers, employees and agents for any and all loss or damage therefore on account of injury to person or property, whether caused by negligence, breach of contract otherwise arising out of or resulting from any act of omission, while traveling to/from or participating in Doggy Paddle Day. I understand that water may carry disease or waste from dogs entering the pool. I agree to hold harmless the Oquirrh Recreation and Parks District, dba Kearns Oquirrh Park Fitness Center, its employees and agents from any liability loss, cost or expense (including attorney's fees, medical and ambulance cost) that I and/or my dog(s) may incur while participating in this recreation activity.
